The American Geographical Society Names Ms. Erica Hagen as EthicalGEO Fellow.

Description: The American Geographical Society (AGS) announces Ms. Erica Hagen as a recipient of the 2019-2020 AGS EthicalGEO Fellowship.

[New York City, NY] – [October 9, 2019] — The American Geographical Society (AGS) has awarded Ms. Erica Hagen an EthicalGEO Fellowship as a result of the Society's recent EthicalGEO Challenge. The EthicalGEO Challenge, in its first year and underwritten by Omidyar Network, solicited videos from across North America and was open to anyone with an interest in exploring the ethical issues involved with the use of geospatial tools and technology. Applicants were instructed to submit a three-minute video explaining their "big idea" or project to address ethics and the use of geospatial tools and technology.

Ms. Hagen, based in Washington DC, is the Director of Map Kibera Trust and GroundTruth Initiative.

Ms. Hagen will use this opportunity to bring together people who are interested in issues of access, power, economics and equity in geographic information. She will create and publish guidelines around ethics of mapping, with a focus on global communities who traditionally have had less access to maps and mapping tools. She will include discussions with a variety of people living in and working with digital mapping in low income countries, informal settlements, remote rural areas, refugee camps, and others often left out of the conversation around sustainable access to and use of geographic data and tools.

"We are very pleased to have selected Ms. Hagen to join this first group of EthicalGEO Fellows. Ethical issues related to the use of geo technology have captured the interest of the media, geo practitioners and everyday citizens. All of us use this technology on a daily basis...be it to find a location using our phones, analyse data in our jobs, or better understand leading headlines in the media. Our use of this technology and data raises serious ethical questions...privacy, ownership of data, use of data...this list is long and growing. Ms. Hagen and the other Fellows will lead the way to help us make better decisions as we rely more and more on geospatial tools and data to live our lives." said Dr. John Konarski, Chief Executive Officer of AGS.

Ms. Hagen will receive a \$7,500 award to carry out her project, participate in a number of special activities and events over the course of the next 9 months, and present the results of her work in a public forum in June of 2020.
